2d. They propose to allot to the Owners of Cottages in Lyddington, Uppingham, and Stoke Dry, three fifth Parts of the Remainder of the Brand, as a Compensation for their Common Rights thereon, in Respect of their Cottage Houses, in certain Proportions, but subject to a Deduction on Account of Tithes.

3d. They propose to allot to the Owners of Lands in Lyddington, Uppingham, and Stoke Dry (except for what was formerly Forest Land or Common), the other two fifth Parts of the Remainder of the Brand, subject to a like Deduction for Tithes.

4th. They propose to divide such Part of Beaumont Chace as they shall adjudge to appertain to Messuages, Cottages, Lands, or Tenements, in the several Parishes having Right of Common thereon, in the Proportions following (that is to say), three fifth Parts thereof unto and amongst the Proprietors of ancient Cottage Rights; and the remaining two fifth Parts thereof unto and amongst the Proprietors of Lands lying within the same Parishes (except in Respect of such Land as has been anciently Common or Forest Land).

ORDERED, That the above Propositions, together with Lists of the Cottages or commonable Houses in Lyddington, Caldecott, Uppingham, Stoke Dry, Wardley, and Aylton; and also of the Yard Lands in Lyddington and Caldecott, as the same are now made out, be printed, and left in some certain Place in each of the said Parishes, for the Inspection and Examination of the said Proprietors; and any of them who hath or have any Objection or Objections thereto, are to signify the same to the said Commissioners, at their next MEETING, to be held at the FALCON INN, in UPPINGHAM aforesaid, on TUESDAY the first Day of SEPTEMBER next, at 10 o'Clock in the Morning; and are to come prepared with Evidence in Support thereof, or Allotments will be made accordingly.
