

The Manor of Siddington in the County of Northampton Memorandum that on the twelfth day April in the year of our Lord 1720: Samuel Rowlett a customary tenant of the Manor also in open Court did surrender into the hands of the Lord of the s^d Manor by the hands of John Blarwell Steward there by the 100 our cottages in Siddington afores^d formerly in tenure of Robert Manton hold by and Copy of Court Roll of this Manor under the yearly rent of two shillings & two pence & also our other cottages in Siddington afores^d formerly in tenure of James Sturkland hold by another copy of Court Roll of this s^d Manor under the yearly rent of one shilling & four pence & also one quarter of a yard land in Siddington afores^d hold by another copy of Court Roll of this s^d Manor under the yearly rent of two shillings & four pence with their appurtenances within the Manor afores^d do the use & behoof of Robert Smith of Waterby in the County of Northampton Yeoman & his heirs & assigns for ever according to the custom of the s^d Manor

provided always & upon this condition nevertheless that if the s^d Samuel Rowlett his heirs Executors or assigns or any of them shall & do well truly pay or cause to be paid unto the s^d Robert Smith his Executors assigns the full & just sum of two hundred pounds of good & lawful money of Great Britain (with interest for the same after the rate of five pounds per hundred annum) at or upon the twelfth day of October next: & using the date hereof then this Surrender to be void & of no effect or otherwise to remain in full force & virtue
